

**ORDINANCE 2005 – A310**

**AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, ADDING ARTICLE 7-9 STORMWATER PROTECTION TO THE TOWN CODE CHAPTER 7 – BUILDING**

The Town Council of the Town of Camp Verde hereby ordains:

Section 1. The Town Council hereby finds as follows:

- A. The Town Council adopted Ordinance 96-A116, adopting the Town Code, which included Chapter 7 Building, Articles 7-1 through 7-8.
- B. The Arizona Department of Environmental Quality has designated the Town of Camp Verde as fitting within the designation criteria of the Clean Water Act Phase II National Pollutant Discharge Elimination System (NPDES) permit coverage.
- C. It is in the Town's best interest to provide for the health, safety, and general welfare of the citizens of Camp Verde, and protect property and prevent damage to the environment by guiding, regulating, and controlling the design, construction, use, and maintenance of any development or other activity that disturbs or breaks the topsoil or results in the movement of earth on land in the Town of Camp Verde and by regulating non-storm water discharges to the public storm drainage system.

Section 2. All ordinances or parts of ordinances adopted by the Town of Camp Verde in conflict with the provisions of this ordinance, or any part of the code adopted herein by reference, are hereby repealed, effective as the day this ordinance is effective.

Section 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason, held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

Section 4. Any person found guilty of violating any provision of this Ordinance shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine or by imprisonment, or both such fine and imprisonment as specified herein. Each day that a violation continues shall be a separate offense punishable as herein described.


