4. Review of the content for the Historical Overview portion of the Design Review Ordinance and identification of opportunities and constraints by conducting a visual survey.



Morris stated that they need a designated staff person for efficient communication, Will Wright was appointed. Gioia read an excerpt regarding Design Review vs. Aesthetic Control. Morris handed out surveys and wanted participation from the Council, Commissioners and Public. Fifteen photos of various buildings were shown and participants were asked to write down their response to several questions regarding each one. The information obtained will be used to formulate a conclusion on what "Western Rural" means.


