We have examined the accompanying Annual Expenditure Limitation Report of the Town of Camp Verde, Arizona, for the year ended June 30, 2017 and the related notes to the report. **NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The annual expenditure limitation report (AELR) is presented as prescribed by the *Uniform Expenditure Reporting System (UERS)*, as required by Arizona Revised Statutes §41-1279.07. The AELR excludes expenditures, expenses, or deductions of certain revenues specified in the Arizona Constitution, Article IX, §20 from the total expenditures, expenses, or deductions reported in the fund financial statements.

In accordance with the UERS requirements, a note to the AELR is presented below for any exclusion claimed on Part II and each subtraction or addition in the reconciliation that cannot be traced directly to an amount reported in the fund financial statements. All references to financial statement amounts in the following notes refer to the Statement of Revenues, Expenditures, and Changes in Fund Balances for the Governmental Funds; Statement of Revenues, Expenses, and Changes in Fund Net Position for the Proprietary Funds; Statement of Cash flows for the Proprietary Funds, and the Statement of Fiduciary Net Position for the Fiduciary Funds.

***NOTE 6 – CONTRIBUTIONS FROM PRIVATE AGENCIES AND ORGANIZATIONS***

The exclusion claimed for grants, aid, contributions or gifts from a private agency, organization, or individual except amounts received in lieu of taxes are consist of donations from individuals and businesses for parks and recreation, police k-9, and other economic development within the Town. Total exclusion totaled \$14,954.

***NOTE 8 – PENSIONS***

The subtraction of \$86,948 for pension expense consists of the change in the net pension liability recognized in the current year in the Enterprise Fund.
