

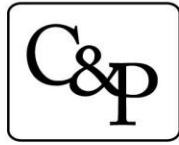

**NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The Annual Expenditure Limitation Report (AELR) is presented on the basis of accounting prescribed by the *Uniform Expenditure Reporting System* (UERS), as required by Arizona Revised Statutes Section 41-1279.07. The AELR excludes expenditures, expenses, or deductions of certain revenues specified in the Arizona Constitution, Article IX, §20 from the total expenditures, expenses, or deductions reported in the fund financial statements.

In accordance with the UERS requirements, a note to the AELR is presented below for any exclusion claimed on Part II and each subtraction or addition in the reconciliation that cannot be traced directly to an amount reported in the fund financial statements. All references to financial statement amounts in the following notes refer to the Statement of Revenues, Expenditures, and Changes in Fund Balances for the Governmental Funds; Statement of Revenues, Expenses, and Changes in Fund Net Position for the Proprietary Funds; Statement of Cash flows for the Proprietary Funds, and the Statement of Fiduciary Net Position for the Fiduciary Funds.

**NOTE 2 – BOND PROCEEDS**

The exclusion claimed for bond proceeds are from a Series 2014 refunding revenue bond for which \$1,372,950 of the bond proceeds was used for the defeasance of the Town’s Series 2005 revenue bond and \$23,802 were bond issue costs. Total exclusion for bond proceeds totaled \$1,396,752.

***NOTE 7 – PENSIONS***

The subtraction of \$74,395 for pension expense consists of the change in the net pension liability recognized in the current year in the Enterprise Fund. The addition of \$34,608 for pension contributions paid in the current year consists of the required pension contributions made to the Arizona State Retirement System from the Enterprise Funds.
