The Fine is \$1,005.00. OR if you provide proof by your appearance date that you had valid insurance on the date of the offense, the charge will be dismissed. Or obtain 6 months of new insurance AND bring a copy of your MVD RECORD showing NO prior Convictions for ARS 28-4135 within the past 24 months or no more than one conviction within the past 36 months prior to your appearance date, fine may be reduced and suspensions waived.

**OPTION 1
DEFENSIVE DRIVING SCHOOL (DDS)**

To Enroll in DDS call 1-888-334-5565 or visit www.azdrive.com

You may divert some civil traffic violations by attending an Arizona state-certified defensive driving school (DDS). **PLEASE NOTE:** You may only divert **ONE** charge on your citation by attending DDS. If you have other charges, you must either plead responsible or not responsible and request a hearing on those charges before the appearance date.

To be eligible:

- Your case has not already been set for a hearing.
- You must not have attended DDS twelve (12) months before the date of the violation for which you are currently charged.
- The charge must be a "moving violation" (denoted on the fine schedule by an asterisk *).
- Your citation was not issued as the result of a collision in which any person was seriously injured or killed.

ENROLL IMMEDIATELY!

You must complete the class no less than seven (7) days before the appearance date listed on your citation.

DO NOT CALL THE COURT TO ENROLL.

If you do not live in Arizona and wish to take a certified Arizona class in your home state, this must be coordinated through a certified Arizona school. Do not do this on your own, as it may not be accepted.

The schools are independent businesses NOT connected to the Court.

If you hold a Commercial driver's license, please go to www.azdrive.com for more information regarding DDS.

Excessive or Criminal Speeding violations (ARS §28-701.02A1, ARS §28-701.02A2, ARS §28-701.02A3). These charges are **NOT** eligible for Defensive Driving and require an appearance before a Judge in Court. **YOU MUST APPEAR AT THE COURT ON YOUR COURT DATE, or a WARRANT MAY BE ISSUED.**

**OPTION 2
PLEAD NOT RESPONSIBLE- CIVIL TRAFFIC
HEARING**

Use the form on the reverse side to request a civil traffic hearing. This request **MUST** be made no later than the appearance date, indicated on your citation. You will be notified by mail/or email of your hearing date.

The purpose of the hearing is to CONTEST the charge(s), NOT to admit them and request a reduced fine. If payments are needed, a \$20.00 Time Payment Fee will apply. Payments are due within thirty (30) days.

If you will have any exhibits (documents, photographs, etc.) You must bring the originals for the Court and two (2) sets of copies for the Officer and yourself.

If you wish to plead responsible for some violations, but not others, please be sure to circle the appropriate charge letter(s).

NOTE: Once you have requested a Civil Traffic Hearing, you no longer have the option of attending DDS (Option 1).

AMERICANS WITH DISABILITIES ACT (ADA)
If you have a disability and need special accommodations for your appearance in court, call this court at (928) 567- 6635. If needed for attendance at a defensive driving school class call any of the Arizona certified schools.

**OPTION 3
PLEAD RESPONSIBLE- PAY FINE**

PAY ONLINE AT: www.azcourtpay.com or www.campverde.az.gov

If you select this option, you are admitting responsibility for the violation(s). The Court will enter a responsible judgment and report the conviction to the Motor Vehicle Division (MVD). Points will be assessed (if applicable) on your driving record for any moving violation -- those violations marked with an asterisk (*) on the fine schedule.

NO PERSONAL OR BUSINESS CHECKS ARE ACCEPTED CASHIER'S CHECK OR MONEY ORDERS ONLY.

You may plead responsible by mail using the form on the reverse side, or in person. The amount of your fine and Court Fees should be on the Fine Schedule on the reverse side of this document. Find your charge and pay the fine for that violation listed on the schedule. If your charge is not listed, CALL THE COURT.

Your fine may be paid by mail, in person, or online.

DO NOT MAIL CASH.

Make your cashier's check or money order payable to **CAMP VERDE MUNICIPAL COURT**. PLEASE WRITE YOUR CASE NUMBER OR COMPLAINT NUMBER ON YOUR CASHIER'S CHECK OR MONEY ORDER.

****NOTICE**

If you plead responsible or are found responsible of ARS 28-645(A)(3)(a) or 28-647.1, state law requires completion of **Traffic Survival School**. MVD administers the program and will provide notification regarding the school.

Traffic Survival School is NOT the same as Defensive Driving School.
