



ORDINANCE 2024-A493

AN ORDINANCE OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, AMENDING THE CODE OF CAMP VERDE, ARIZONA, CHAPTER 3 ADMINISTRATION, ARTICLE 3-1 OFFICERS IN GENERAL, SECTION 3-1-3 REMOVAL PROVISIONS, ARTICLE 3-2 OFFICERS, SECTION 3-2-1.1 ACTING TOWN MANAGER, AND SECTION 3-2-4 TOWN MARSHAL, RELATED TO ENSURING CONTINUITY OF TOWN OPERATIONS BY UPDATING REGULATIONS GOVERNING APPOINTMENT, SERVICE, AND RESIGNATION OF OFFICERS; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the Mayor and Council desire to amend Town Code requirements governing the appointment, service, and resignation of Town officers; and

WHEREAS, the amendments will ensure the continuity of Town operations and the provision of government services for the benefit and welfare of residents;

NOW THEREFORE, BE IT ORDAINED by the Council of the Town of Camp Verde, Arizona, as follows:

Section 1. General.

The Code of Camp Verde, Arizona, Chapter 3 Administration, Article 3-1 Officers in General is amended by amending Section 3-1-3 Removal Provisions to read as follows (additions in ALLCAPS; deleted text in ~~strikeout~~):

SECTION 3-1-3 REMOVAL PROVISIONS

* * *

C. Resignation. The Manager shall provide the council with ~~thirty (30)~~ SIXTY (60) days' written notice of intention to resign his/her position. Department heads shall provide the Town Manager with thirty (30) days written notice of intention to resign.

The Code of Camp Verde, Arizona, Chapter 3 Administration, Article 3-2 Officers is amended by amending Section 3-2-1.1 Acting Town Manager to read as follows (additions in ALLCAPS; deleted text in ~~strikeout~~):

SECTION 3-2-1.1 ACTING TOWN MANAGER

* * *

B. If the Town Manager will be absent for more than thirty (30) days, is suspended by the Council, or if there is a vacancy in the office of the Town Manager, the Council shall appoint a qualified Acting Town Manager to serve until the Town Manager returns, the suspension ceases, or until another Town Manager is appointed. TO ENSURE THE CONTINUITY OF TOWN OPERATIONS, THE DEPUTY TOWN MANAGER, TOWN MARSHAL, AND FINANCE DIRECTOR, IN THAT ORDER OF SUCCESSION, ARE HEREBY DESIGNATED TO SERVE AS THE ACTING TOWN MANAGER UNTIL SUCH TIME AS COUNCIL ACTS TO APPOINT AN ACTING TOWN MANAGER IN ACCORDANCE WITH THIS SECTION.

The Code of Camp Verde, Arizona, Chapter 3 Administration, Article 3-2 Officers is amended by amending Section 3-2-4 Town Marshal to read as follows (additions in ALLCAPS; deleted text in ~~strikeout~~):

SECTION 3-2-4 TOWN MARSHAL

* * *

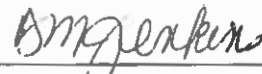
A. Office Established. The office of the Town Marshal is hereby established. The Town Marshal shall be appointed by the Town Manager on the basis of ability, and shall hold office pursuant to Section 3-1-3.A of this code. THE TOWN MARSHAL IS REQUIRED TO ESTABLISH RESIDENCY WITHIN THE TOWN OF CAMP VERDE AS PRESCRIBED IN SECTION 3-1-1 OF THIS CODE. ~~Prior to January 2014, the Town Marshal shall be a resident of the Town, unless such requirement is waived by the Council. After January 2014, the Town Marshal is required to establish residency within the Town of Camp Verde Town limits or the 86322 Zip Code area within 120 days of the date of hire. There are no exceptions to this requirement.~~

Section 2. **Providing for Repeal of Conflicting Ordinances.** All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference are hereby repealed.

Section 3. **Providing for Severability.** If any section, subsection, sentence, clause, phrase, or portion of this Ordinance or any part of the Code adopted herein by reference is, for any reason, held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

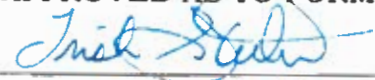
