The winning bidder will be notified of the acceptance of the bid by September 5, 2019 and all bidders will be notified of the results by September 6, 2019. The winning bidder needs to make pickup/delivery arrangements no later than September 13, 2019 and deliver/pickup by September 27, 2019.
