**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN
OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA,
APPROVING THE EXECUTION OF AN INTERGOVERNMENTAL
AGREEMENT WITH THE TOWN OF CHINO VALLEY FOR
A LIBRARY CIRCULATION DESK**

WHEREAS, the Town of Camp Verde ("Town") and the Town of Chino Valley desires to enter into an intergovernmental agreement that will serve the needs of both communities;

WHEREAS, the Town of Chino Valley has a Library Circulation Desk that it wishes to exchange for a Camp Verde Library list of software;

WHEREAS, the parties are authorized to enter into agreements for joint or cooperative action pursuant to ARS §11-951 and 11-952; and

WHEREAS, Arizona revised statutes authorize towns to receive, hold or dispose of gifts made to them for library purposes and towns may apply them in a manner which will best promote the uses of the library pursuant to ARS §9-412;

NOW THEREFORE, the Mayor and Common Council of the Town resolve to enter into the proposed intergovernmental agreement with the Town of Chino Valley as presented and approved by the Council at the Regular Session of February 6, 2002.

INTERGOVERNMENTAL AGREEMENT

The Town of Chino Valley agrees to furnish a used Library Circulation Desk to the Town of Camp Verde.


The Town of Camp Verde agrees to provide the Town of Chino Valley with a list of software used by the Town of Camp Verde Library.


